GOODS IN TRANSIT

The policy covers (subject to its terms, exceptions and conditions) goods carried in an Insured's owned or hired vehicles whilst in transit against LOSS, DAMAGE OR DESTRUCTION By accident or misfortune arising from any fortuitous circumstance, including FIRE, THEFT AND ACCIDENTAL DAMAGE.

PRINCIPAL EXCLUSIONS

The Policy excludes liability in respect of:

- (1) Loss or Damage caused by Deterioration, Vermin, Inserts, Mildew, Rust Damp, Climatic or atmospheric conditions, Delay or Loss of Market.
- (2) Any consequence of Earthquake or Volcanic Eruption, War, Invasion, Acts of Foreign Enemy, Hostilities (Whether war be declared or not) Civil War, Rebellion, Revolution, Insurrection, military or Usurped Power, Confiscation, Destruction, Requisition or Detention by or under the order of any Government or Public or Local authority.
- (3) Theft or Pilferage in which the driver of the vehicle or any other employee of the insured is concerned as principal or accessory.
